



Fitch: DKT's Norwegian Asset Sale Supports Deleveraging

Fitch Ratings-Moscow-19 July 2018: Fitch Ratings says the plan of DKT Holdings ApS (DKT; B+/Stable), the owner of Danish telecoms company TDC A/S (TDC), to sell Get AS, its Norwegian business, to Telia Company AB (Telia) should result in lower leverage while the exact impact on its credit profile and instruments ratings will depend on the deployment of sale proceeds.

On a pro-forma basis the sale should reduce DKT's funds from operations (FFO) adjusted net leverage to around the upgrade threshold of 5.7x at end-2018, compared with the estimated 6.7x without the Get disposal. At the same time the proceeds should allow the company to accelerate its investments in fibre infrastructure in Denmark, in line with the shareholders' long-term strategic targets. Clarity on the use of the proceeds as well as on DKT's target capital structure and investment plans would be required before we consider any rating action. We expect to have more information closer towards deal completion, targeted in 2H18.

The shares of Get are a main component of TDC's EUR3.9 billion term loan's security package along with bank accounts, intra-group receivables and the shares in TDC, so the sale of the asset implies that the term loan will no longer benefit from superior recoveries. The Recovery Ratings of the instruments will depend on the amount of proceeds used for debt prepayments after the sale.

Fitch understands from management that the disposal of the Norwegian assets is part of the shareholders' long-term strategy. The shareholders intend to split the company into two, creating a customer-facing service unit and a wholesale network company. The latter will become a utility-like regulated wholesale telecom operator generating stable long-term returns. We expect these changes to take a few years. We have not incorporated these long-term changes into our rating and treat such a development as event risk due to uncertainties over regulation, the terms of any network separation and impact on capital structure, among others.

DKT's subsidiary TDC announced a sale of its Norwegian business (Get and its subsidiaries including the Norwegian B2B business and TDC Norway) for NOK21 billion (around DKK16.5 billion) on a cash and debt-free basis valuing Get at 12x of its 2017 EBITDA. The deal is subject to regulatory approval.
