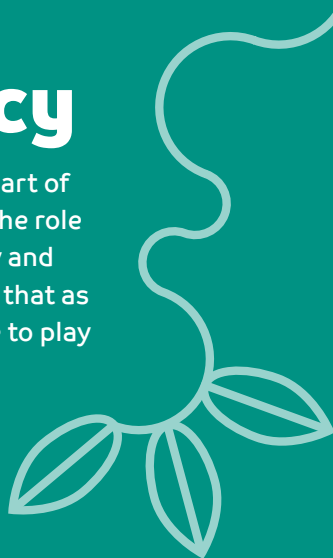
Sustainability Policy
